TOD Questions


- How many residences, businesses, schools, recreation, etc. can fit in a ¼ mile radius?


Illustrating Inadequacy of Current Light Rail and TODs

Case Example: How to use get from Littleton to IKEA in Centennial?

Littleton → IKEA: Light Rail




Cost: \$8 Light Rail



1.2 mile walk

Total: 1 hr. 15 min


Littleton → IKEA: Bike



12.1 miles, 1 hr 15 min.

Not sure if all roads are bike safe

Littleton → IKEA: Car



13.6 miles, 21 min.

Roundtrip Cost ~ 1 gallon gas (\$3.50 - \$4.00)

MOD

Mobility Oriented District

- Goal: Live, Work, Play comfortably without a owning a car
- MOD = TOD with secondary transportation options
- Increase "TOD radius"
- Use Light Rail for regional travel
- Use secondary transportation for local travel around light rail stations
- Link fares for light rail and secondary options so as to keep affordable for families

Example Secondary Transportation Options

Bike Sharing/Rental Stations







- LSV (Low Speed Vehicle) Sharing/Rental Stations
 - Legal on Roads with Speed Limits <= 35 MPH








Mobility Diagram









TOD Case Study: Littleton

 - Getting to daily living needs, not so easy.


Example Secondary Transportation



Walking Radius




Bike Radius
